The point(s) at which fish and fish products may enter a chain of custody:

The existing certified PNA free school tuna fishery (PNAFTF) is recognised as having a rigorous traceability monitoring system in place, that includes catching and transhipment of the tuna up to the point of discharge to the processing factory. Under the reassessment of the PNAPSF, catches of skipjack tuna, yellowfin tuna and bigeye tuna taken inside the PNA EEZ within all set types are eligible to enter further certified chains of custody and will be eligible to be sold as MSC certified and carry the MSC ecolabel.

Noting the steps laid out below, there is no at-sea processing, and traceability is undertaken to the point at which the fish are delivered to a factory and are finally confirmed as being MSC-eligible. This is also the point at which change of ownership occurs. MSC Chain of Custody is required from that point forward.

Only registered vessels are eligible to harvest and land tuna with the MSC claim subject to the following provisions:

- a. PNA has approved and documented the trip as an MSC-eligible trip,
- b. A specially trained MSC fisheries observer is placed on board for the duration of the trip,
- c. The fish is only considered MSC eligible until landed and exact weights verified,

No Inseparable or Practically Inseparable catches are currently allowed on this certificate. Processing of domestic and Distant Water Fishing Nation (DWFN) vessel catches takes place in Papua New Guinea, Marshall Islands and Solomon Islands. However most is typically transhipped in PNA ports designated for transhipment to be shipped to processors in non-PNA countries.

Note: The PNA tuna fishery UoCs 1-3 cover skipjack, yellowfin and bigeye tuna catches taken in all purse seine set types from within the PNA EEZs. Separation of catch by set type is not required routinely for MSC CoC. However, other second-party or third-party processes may verify separation of catches by set type if deemed necessary for commercial or other reasons. For example, catches may be identified as 'free school' and then stored separately in specific wells or by using double-netting in wells, together with appropriate record-keeping by independent observers and practices during loading, transhipping or offloading. Such separation would be additional to MSC traceability and COC requirements.
