#### Background

#### Scope of Work

The consultant shall:

- a) Collect and analyse key documents (the Nauru Agreement and PNA Arrangements, relevant PNA Meeting papers and reports, PNA Leaders' Summit outcomes, Annual Reports and Business Plans, Financial Reports, and other relevant documents).
- b) Consult with the PNAO CEO and senior staff.
- c) Review the major elements of the current Plan:
  - PNA Vision
  - Values and Principles
  - Basis for Cooperation
  - Role of the PNAO
  - Mission Statement
  - Objectives
- d) Consult with current, previous, and next PNA Chairs (FSM, Solomon Islands and Kiribati)
- e) Prepare an evaluation of the current Strategic Plan addressing:
  - How effective has the current Plan been in *"guiding cooperation amongst the Parties and the technical work of the PNA Office"*?
  - What has changed in the strategic environment for PNA since 2019?
  - What, if anything, should be removed and what new elements should be included into the next Strategic Plan?
  - What, if any, shifts in focus should be included in the next Strategic Plan?
- f) Suggest areas of change for the next Strategic Plan to be considered by Parties.
